## Managing Uncertainty in an Explosive Hazard Contaminated Environment – The Survey, Prioritisation and Clearance of Recovered Areas in Southern Tripoli and Beyond

The landscape of southern Tripoli has been littered with explosive hazards. Booby traps, landmines and Improvised Explosive Devices faced the anxious returnees. The threats exhibited a level of sophistication and ingenuity beyond the training and experience of many of the clearance organisations. The LibMAC, as the de facto National Mine Action Authority, undertook the task of coordinating the survey, prioritisation and clearance necessary to facilitate safe and dignified returns. Despite a concerted effort by governmental and non-governmental clearance organisations, there were casualties. Dedicated resources were, and still are, needed to sustain existing operations and to scale up activities to implement the Ceasefire Agreement and capitalize on the opportunities it creates.

#### Impact of Explosive Ordnance on Vulnerable People in Syria, Specifically Children

In Syria, 1 out of 4 victims of landmines and Explosive Ordinance (EO) is a child, and men and boys are considered to be the most exposed to the risk of explosive ordnance. This side event will highlight the impact of landmines and explosive ordnance on children, as well as the people across Syria, and also discuss challenges faced in the implementation of Mine Action activities. We also plan to shed light on the role of volunteers, and our efforts in dissemination of risk education messages in the areas difficult to reach.

#### Doing it Right, Doing it Better: EORE Voices from the Field

This side event will spotlight the experiences and innovations of the field practitioners working at the forefront of explosive ordnance risk education, showing how local organisations and communities are persevering in the face of challenges. #### Approaches to Counter the Threat Posed by IEDs – Examples from Yemen and the Sahel Region

The event will expose the challenges posed by improvised explosive devices in the Sahel region and Yemen. It will demonstrate novel human-rights based capacity development interventions based on the UNIDIR C-IED model and how such interventions could be implemented by other Member States. It will describe how life and livelihood can be saved through a focus on community consultation, IED disposal training and risk education, and how strengthening the evidential process, explosive hazard data collection and mitigating the illicit diversion of explosive precursors and IED components can restore confidence in the Rule of Law.

#### Long Term Impacts of Explosive Weapons in Populated Areas – Implications for the Mine Action Sector

The humanitarian consequences of the use of explosive weapons in populated areas (EWIPA) are immense. This event will explore the challenges that urban contamination resulting from the use of EWIPA poses for mine action operations. It will explore how operators are responding to these challenges through innovation, partnership and people-centric approaches. It will also highlight findings from 10 years of data collection on EWIPA. All this against the backdrop of ongoing diplomatic negotiations on a political declaration on EWIPA, led by Ireland.
