# Successes in Mine Action by the UN Mine Action Team over the Past 12 months

- Improved coherence across the sector – One UN Mine action Team (all UN Agencies)
- Adoption of a national strategy (UNDP, GICHD)
- Acceptance of a risk management approach – particularly facilitating returns and agricultural production (WFP, UNDP, FAO, RCO)
- Adopting an outcome, not only output approach to the sector by all stakeholders (all UN Agencies)
- Creating of sectorial working group (SWG) co chaired by Ukraine DPM, Ambassador of Japan and RC (RCO, UNDP)
- Revision and roll out of some national standards (UNDP, GICHD)
- Relaunch of the Mine Action AoR (UNDP)
- Proof of concept for release of agricultural land (WFP, FAO, UNDP, UNOPS)
- High impact risk education (UNICEF & UNDP)
- 3 local MASG meetings convened (UNDP, RCO)
- Use of technology to undertake remote assessment of potential contamination (all UN agencies)
- Trails of UAV and new detection systems (UNDP, WFP)
- Arrival in country of Dog teams to prove areas free from contamination (no evidence of mines) rather than find mines (UNDP)
- Advocating for and delivering innovative Victim Assistance Projects across Ukraine (UNDP, UNICEF)



# Priorities for 2024 and beyond

- Support the Government especially implementing National Strategy
- Support sectorial working Group
- Expansion of capacity
- Improved tasking and coordination – outcome driven prioritization and tasking
- Data driven prioritization
- Improve logistics and supply chain for mine action projects in Ukraine
- Develop local demining capacity (not just deminers, but all skills needed)
- Develop local production facilities to support mine action projects
- Synchronization of data
- Adoption of new technologies
- Identify new potential sources of financing
